1. Provide clarification and answers to questions from potential suppliers.

QUESTIONS AND ANSWERS:

Question 1	We were just informed by OEM that the requested model (the CL17-17) does not have brakes. Will Canada accept removing this requirement?
Answer 1	No, The Department of National Defence will not remove this requirement.
Question 2	Ref: 3.16.1 The trailer must be provided with an electric brake system powered from the towing vehicle through the 7-pin trailer harness. These trailers do not require brakes per CMVSS. However, if you want brakes on these, we will put surge disc brakes, which are more durable. The other option is electric drum brakes that will fail in 6 to 12 months, so we do not recommend them. Would you please let us know if you accept surge disc brakes?
Answer 2	The Department of National Defense approves surge disc brakes but requires that the Trailer Break Away system in accordance with paragraph 3.17 must be integrated into the braking system.
Question 3	Ref: 3.7.3 All fasteners must be hot dipped galvanized. Do you accept Zinc plated fastener instead of hot dipped galvanized? Hot dipped galvanized fasteners are not practical, and we can provide more details if you require.
Answer 3	Department of National Defence will accept proposed Zinc Plated fasteners in lieu of hot dipped galvanized as indicated in Para 3.7.3 with a rubber or sealant to keep the metals as separate as possible even when they are compatible metals
