Amendment 005 is raised to:

- 1) Extend the closing date for the Bid Solicitation until 14:00 Eastern Time on 13 October 2023.
- 2) Answer question(s) from Industry:

Question 1: We are in receipt of this revised TDL and we noted that for RFP item 21 part number 0777978-1 the original TDL (August 2023) the drawing is at revision NC (original issue with no changes) yet the TDL from September 7/23 shows revision A (page 14 of the DDL is attached). Drawing 0777978-1 revision A to match the new DDL is now required as it was not included in the revised TDL.

Response 1: DSCO 4 confirms that the TDP provided for the subject procurement contained the current engineering drawings from the engineering drawing repository.

Question 2: For RFP item 17-part number 1277692-1 – on the BOM item 104 part number 1277702-1 does not show a quantity per (it is blank). Please confirm the quantity per assembly.

Response 2: Looking at the next higher assembly, for Part Number 1277702-1, there is Qty 1 - required per assembly.

Question 3: Do you have the STP files for the drawings listed under NSN 5340-20-012-4099 BRACKET, MOUNTING (GAJT) and can you release it?

Response 3: The STP Files are only required by the Supplier during the manufacturing process. They are not required during the RFP process. Potential bidders receive the DSCO drawings which should be sufficient for them to submit a bid.

Question 4: Our painters are declining to quote the finishing because spec MIL-DTL-53084 is calling for - The primer required is an E-coat, electro dip process commonly used in automotive, followed by a traditional powder coat – and they do not offer E-coat process (Dip Process) Is there possibility for another primer application?

Response 4: The following response is from the TA for Land Coatings:

I assume you require a CARC compliant coating system for which a MIL-DTL-53084 primer was specified but industry does not have the equipment/capability to apply this primer, therefore, you are looking for an alternative that is equivalent. If this is in fact the case, any of the below primers can be used as an alternative:

- 1) MIL-DTL-53022 Ty IV solvent bourne two component primer applied with spray gun. NSN 8010-01-589-7077. This is the most common primer used at DND/CAF facilities.
- MIL-DTL-53030 Ty II water bourne two component primer applied with spray gun. NSN 8010-01-603-2127. While compliant with CARC requirements, this primer can be difficult to work with so that the water content does not cause flash rusting;
- 3) MIL-PRF-32348 Ty I powder coating to be applied under CARC topcoat. NSN 8010-01-592-0167.

Question 5: After further review on part number 1277692-1's bill of material, it is noted that over and above item 104, items 407, 408, 409, 410 & 603 do not have quantities per shown on the BOM. Please advise the quantity per for these items so that we can bid correctly.

Response 5: See attached for Drawing 1277692, Sheets 1-2-3-4-5-6, Bracket KG-175D, SCBU Mounting.

Question 6: As a follow-up to Amd 004 where the closing date was extended to 2-Oct 2023 and the requested delivery date also extended from 30-Nov-2023 to 5-Jan-2024. Can the bidder offer a later delivery date, as long as it is in this current FY-23-24, i.e., before March 31st, 2024?

Response 6: The bidder may offer a different delivery date than what has been requested.

Question 7: With respect to drawing 1277703-1, the length and width are noted on the drawing but the height of the part is missing.

Please advise what this dimension is so we can quote it.

Response 7: Please refer to the attached redline drawing of 1277703 which indicates bracket height dimension of 9.50mm.

Question 8: With respect to RFP item 34 - drawing 1698265-1 (attached) item 9 on the BOM (part number 4140) is for a padlock. The padlocks required can be keyed individually or keyed all the same.

The keying is not noted on the drawing so please advise how you wish these locks to be keyed and please advise how many keys per lock do you wish.

Response 8: Each padlock will require two (2) keys and the padlocks should be keyed individually.

All other terms and conditions remain unchanged.
