



## **ADVANCED CONTRACT AWARD NOTICE (ACAN)**

### **Advance Contract Award Notice (ACAN)**

1. An Advance Contract Award Notice (ACAN) allows departments and agencies to post a notice, for no less than fifteen (15) calendar days, indicating to the supplier community that it intends to award a good, service or construction contract to a pre-identified supplier. If no other supplier submits, on or before the closing date, a Statement of Capabilities that meets the requirements set out in the ACAN, the contracting authority may then proceed with the award. However, should a Statement of Capabilities be found to meet the requirements set out in the ACAN, then the contracting officer will proceed to a full tendering process.

### **2. Definition of the requirement**

- The Royal Canadian Mounted Police (RCMP) has an ongoing need for speed-measuring equipment that is required to enforce vehicle speed regulations by delivering to RCMP Regional Detachments and Traffic Services units' located across Canada.

### **3. Criteria for assessment of the Statement of Capabilities (Minimum Essential Requirements)**

Any interested supplier must demonstrate by way of a statement of capabilities that its product/equipment/system (as appropriate) meets the following Multi-Mode Two (2) Zone RADAR requirements:

- DSR 2X Dual Zone w/LCD display Part # 807-0001-00
- must operate in Ka band only;
- must include two (2) antennas; Front Antenna Cable – 4 foot #155-2591-04/ Rear Antenna Cable – 20 foot #155-2591-20;
- must include a speedometer interface;
- must include directional sensing/discriminating capabilities;
- must have separated speed displays; target, fast/locked, and patrol;
- must display speeds in kilometers per hour (km/h) only;
- must be equipped with a remote control to operate the RADAR Part # 200-0919-00;
- must have a separable display which includes all necessary separation kit components, cabling and all mounting hardware to allow for the separation of the display;
- must include (as a minimum) a three (3) meter cable assembly that will be used for connecting the RADAR's display unit to the RADAR's processing unit to allow for separation of display; Part #155-2211-25;



- must have a “Fast” feature that displays the fastest target speed in the beam regardless of direction;
- must have graphics on the front indicating direction of the targeted vehicle;
- whenever a target is locked, it must have an audible voice tell the operator which antenna is in use, what mode the RADAR is operating in, and the direction the targeted vehicle is travelling;
- must have a patrol vehicle speed window that continues to run after the target speed is locked allowing for ongoing tracking history;
- must be able to display both rear and front antennas at the same time utilizing additional display windows;
- must be equipped with a remote control to operate the RADAR. Part # 200-0919-00.

#### 4. **Applicability of the trade agreement(s) to the procurement**

This procurement is subject to the following trade agreement

- Canadian Free Trade Agreement (CFTA)

#### 5. **Justification for the Pre-Identified Supplier**

Mega Technical Holdings Ltd is the only supplier capable of performing the work as they hold a patent on a multi-mode two zone RADAR device that must be able to display both rear and front antennas at the same time utilizing additional display windows

#### 6. **Government Contracts Regulations Exception**

The following exception to the Government Contracts Regulations is invoked for this procurement under subsection subsection 6(d) - only one person is capable of performing the work.

#### 7. **Exclusions and/or Limited Tendering Reasons**

The following exclusion(s) and/or limited tendering reasons are invoked under the

- Canadian Free Trade Agreement (CFTA) – Article 513 (b) CFTA is applicable as the goods or services can be supplied only by a particular supplier and no reasonable alternative or substitute goods or services exist for any of the following reasons: v. to ensure compatibility with existing goods or to maintain specialized goods that must be maintained by the manufacturer of those good or it representative.



## **8. Period of the proposed Standing Offer or delivery date**

- The proposed Standing Offer is for a period of 1 year, from an estimated start date of November 30, 2023 to an estimated completion date of November 30, 2024. The Standing Offer includes three (3) one-year option periods.

## **9. Cost estimate of the proposed contract**

The estimated amount of the standing offer is \$350,000.00 (including HST). There will be three (3) one (1) year options to renew under the same terms and conditions estimated at \$350,000.00 each (including HST). Call-Up limitation of \$40,00.00(including HST). Canada may exercise this option at any time by sending a notice to the Contractor prior to the Contract expiry date.
