Answer 19	Due to email size restrictions, Bids now must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by using the Canada Post Corporation's Connect service as per specified in the article 8.2 of the <u>2003 Standard Instructions - Goods or Services - Competitive Requirements</u> as per specified at points 5 and 6 of this amendment.

2.2 Submission of Bids

- A. Bids must be submitted only to the Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time, and place indicated on page 1 of the bid solicitation.
- B. Due to the nature of the bid solicitation, bids transmitted by facsimile will not be accepted.

Submission of Bids – Canada Post Corporation's Connect service ONLY (All pdf files if used must be submitted in an unlocked format.)

Bids must be submitted only to Public Services and Procurement Canada (PSPC) - via Canada Post Corporation's (CPC) Connect service by the date, time and place indicated in the bid solicitation.
