QUESTIONS & ANSWERS

Q1 Is there a preliminary construction budget/estimation available for the project?

A1 Yes \$3m with 30% expected to reduce to 5-10% at IFT package completion.

Q2 Energy supply is by generator/solar array power. Heating is by propane tanks. Will the consultant be required to analyze the propane tank capacity and determine whether additional storage capacity is required, or will this be done by the propane tank supplier?

A2 No. The intent is to replace and not expand the staff housing offering with a future de-commission of buildings. PCA's intent is to align to Net Zero goals published in GGS strategies.

Q3 Does the site have a permanent maintenance personnel on site or nearby for maintaining and repairing M&E systems?

A3 Yes. (Banff Field Unit) BFU has full trade complement in Banff to answer service calls to Ya Ha M&E systems.

Q4 It is understood PCA intends to have a new treatment system for the new groundwater source. Please advise if the proponent is to provide a design or source a system suitable to treat the raw water quality, or will this equipment be sourced by PCA?

A4 Proponent will not be required to provide A&E design for water treatment. This is being designed within PCA and will be adopted into this site.

Q5 What is intended for the existing raw water and potable water systems? Will decommissioning them / or their removal be part of the scope?

A5 Raw water system is to be preserved for livestock watering. Removal is not part of scope.

Q6 Are existing geotechnical and water quality reports available for review during the RFP stage?

A6 These documents will be provided to the successful proponent after award. They include the 2018 Geotechnical investigation adjacent to proposed triplex site, 2010 ESA for septic listing metal contaminants but not septic performance, and full site survey, ground and drone supported 2021.

Q7 Site restoration design is excluded from scope, does this include landscape design, drainage and site grading?

A7 Site restoration and design is not required. Minimal grading for water shed away from the building and provision for parking is required.
