Definition of a Day/Proration

A day is defined as 7.5 hours exclusive of meal breaks. Payment will be for days actually worked with no provision for annual leave, statutory holidays and sick leave. (Hours worked × applicable firm per diem rate) ÷ 7.5 hours.
