1. Cover Page, A7. Proposal Delivery:

DELETE:

“In order for the proposal to be valid, it must be received no later than **14:00 EST on January 31, 2024**, referred to herein as the “Closing Date”. Electronic proposals must be sent only to the following email address: realproperty-contracts@international.gc.ca.”

INSERT:

“In order for the proposal to be valid, it must be received no later than **14:00 EST on February 2, 2024**, referred to herein as the “Closing Date”. Electronic proposals must be sent only to the following email address: realproperty-contracts@international.gc.ca.”

2. Cover Page, A11. Language:

DELETE:

“Proposals shall be submitted in English, or French.”

INSERT:

“Proposals shall be submitted in English, French or Spanish.”

3. Request for Proposal, Part 2 – Technical Mandatory Requirements, 3.0 Mandatory Criteria, Mandatory Requirement, M1:

DELETE:

“The Bidder must submit 2 projects demonstrating their painting experience in commercial or residential buildings completed in the last two years of bid closing.”

INSERT:

“The Bidder must submit 2 projects demonstrating their painting experience in commercial or residential buildings completed in the last 3 years of bid closing.”



4. Request for Proposal, Part 2 – Technical Mandatory Requirements, 3.0 Mandatory Criteria, Compliance, M2:

DELETE:

“Bidder must provide: 1. Description of experience in the last 2 years coordinating a team of workers in a painting project.”

INSERT:

“Bidder must provide: 1. Description of experience in the last 3 years coordinating a team of workers in a painting project.”

5. Draft Contract, Article C9. Insurance:

DELETE:

“The Contractor shall provide a comprehensive general liability insurance of \$ 1 Million CAD in accordance with the Insurance Conditions (Section “IV”).”

INSERT:

“The Contractor shall provide a comprehensive general liability insurance of \$ 500,000 CAD in accordance with the Insurance Conditions (Section “IV”).”

6. Draft Contract, Appendix “A” – Statement of Work:

DELETE:

“5. INSTALLATION

The contractor shall install the new quarter rounds upon completion of painting baseboards. Quarter rounds are supplied by DFATD and the Department Representative.”

All other conditions and requirements remain unchanged.
