- **Q1.** "In Section "V" M1 the projects are to have met substantial completion in the last 10yrs from ITQ closing date. Can this be altered to the last 15yrs?"

- **Q2.** "Section "V" Pre-Qualification Requirements: The boundary walls in our projects are ones with columns and plinth beams with brick panels constructed at site. Precast concrete boundary walls are not common in India. Most construction in India is cast-in-situ and built on site as the industry is labour intensive. Does that disqualify us from this ITQ?"

- **Q3.** "Statutory Approvals: Request to provide clarity on the list and scope of Design Builder in obtaining statutory approvals required to start the project as mentioned below:
