# **ADVANCE CONTRACT AWARD NOTICE (ACAN)**

## 1. Advance Contract Award Notice (ACAN)

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

## 2. Definition of the requirement

The Department of Natural Resources Canada (NRCan) requires an Open License on LiDAR data acquired in 2021 in the Lloydminster region. The license must be compatible with the Open Government License – Canada: <u>https://open.canada.ca/en/open-government-licence-canada</u>.

This type of licence allows the use and distribution of the LiDAR data and derivative products generated by the Government of Canada to the entire population without restriction.

The requirements for the acquisition of airborne LiDAR data are summarized in Table 1.

Any interested supplier must demonstrate by way of a statement of capabilities that it meets the following requirements:

The supplier :

- Must own copyright on LiDAR data collected in 2021 in the Lloydminster region.
- Must be the manager of these copyrights and allowed to grant any license rights for the use of these data.
- Must authorize an open license on LiDAR data compatible with the Open Government License Canada: <u>https://ouvert.canada.ca/fr/licence-du-gouvernement-ouvert-canada</u>.

The LiDAR data obtained under this license must cover the Lloydminster region Greater Toronto and have the characteristics described in Table 1 of the previous section.

## 4. Applicability of the trade agreement(s) to the procurement

## 5. Justification for the Pre-Identified Supplier

Should Canada receive a statement of capabilities from a supplier that contains sufficient information to indicate that it meets the requirements set forth in this ACAN, a competitive process will be triggered with a technical and financial evaluation methodology of the bids proposed by the potential bidders
