This amendment is raised to answer a technical question from a potential bidder.

The question is:

“According to the received information from the OEM, the shelf life of the mentioned solicitation product reagents is 24 months. In reference to Clause 6.15 Shelf Life on page 14, is a maximum shelf life of 24 months acceptable?”.

Answer:

A maximum shelf life of 24 months is acceptable.

Clause 6.15 Shelf Life is amended to read as follows:

“The Contractor must ensure that items 001 to 002 will contain 75 percent of the authorized shelf life as listed in CFTO D-05-001-001/SF-000 at date of delivery to the Department of National Defence.

Maximum shelf life for items 001 to 002 is 24 months.”

All other terms and conditions remain the same.
