

Response(s) (R) to Question(s) (Q)

Q1. On page 23, we can read:

The Bidder must provide <u>three</u> (3) reference contracts for client organization(s) demonstrating professional work experience providing graphic design deliverables that are the same or similar\* to those described under section 3.3.1 Visual Design and/or 3.3.2 Digital Platform Design, of the Annex A - Statement of Work (SOW).

Do we really have to add a minimum of 3 signed contracts, or does this refer to the contract summary as described below on the same page?

R1. The Bidder does not need to provide signed copies of the contracts. The bidders are required to provide the specific information requested, this includes i) a summary of the contract's objectives, requirement, and the Bidder's contribution including a description of services provided and a list of deliverables; and ii.) a minimum of two examples of design products delivered, as a separate attachment or in thumbnail format. The Bidder must also complete Template A providing all the required information.
