- Q21. Sections 1.5, 2.5 etc. have Fire Alarm parts listed with 1 device, and a unit price. The text content in the header section refers to firm hourly labour rates, however the pricing grid mentions 1 device and per unit rate. Is the RFQ asking for the replacement price of the specific Fire Alarm Parts, or labour rates? As the parts to replace are particular to the manufacturer/supplier (Edwards/FireShield), there is no possibility a 3<sup>rd</sup> party service provider can supply a part at a low(er) price for bidding. Programming and parts are always specific to the Fire Alarm manufacturer.**
- A21.** Please refer to the corrected and amended Basis of Payment. Cost for parts will be included under Parts and Materials. Hourly rates are separate from Parts and Materials.
- Q22. Can you bid on the RFQ without the Fire Alarm pricing for inspections/parts, and just bid on Sprinkler only?**
- A22.** No. Bidders must provide pricing for all services.
