024	In view of submitting a satisfactory proposal, we kindly request if the submission deadline can be reported to a later date. An extension of one (1) week, considering that March 29th and April 1st are holidays, would be helpful bringing the submission date to April 9, 2024?	The closing date and time will be updated to 19 April 2024, 14:00 EDT in a subsequent amendment.
025	In each of the mandatory criteria in the RFP, the text stipulates work performed by an SME must be demonstrated for at least “three different client organisations.” Would DND consider modifying this text to stipulate “three different projects”? In its current wording, the text is restrictive and does not allow for distinct projects with the same client (i.e. Ontario Ministry of Health).	Each of the mandatory evaluation criteria will be modified from “... at least three different client organizations.” to “... at least three different projects” in a subsequent amendment.
026	Regarding Phase 1 activities associated with data model creation and analysis of systems including Purkinje, Softlab, SoftRad, Iris, and ADSTRA, do other data sources as outlined in the EHRP Concept diagram such as external HR Resource System Data, FHCPS Data, NATO Information Systems, require analysis or is the scope of analysis limited to the systems associated with CFHIS?	The scope of the data model creation and analysis is limited to the systems associated with CFHIS.
027	Will samples of data be provided from CFHIS systems for activities associated with data quality assessments (3.1.2)?	Yes.

028	Does documentation currently exist for CFHIS systems in relation to the data schemas and metadata?	Documents exist regarding CFHIS database schemas and metadata, though they are likely not 100% complete, since the CFHIS environment, as well as metadata standards, continue to change and evolve.
029	What level of involvement is DND anticipating for its internal resources to support Phase 1, 2, and 3 activities?	The successful bidder will have access to DND internal resources to assist with all phases of the contract by providing access to data and existing documentation and policies as required.
030	Does DND expect proponents to engage with external DND partners directly (e.g. representatives from Purkinje, SCC, ADSTRA, InterSystems etc.) or will contact be facilitated by internal DND resources?	Contact with DND partners will be facilitated by internal DND resources.
031	Is it possible to request an extension to submit April 19?	The closing date and time will be updated to 19 April 2024, 14:00 EDT in a subsequent amendment.
