## **Amendment 002**

This amendment is raised to:

- A. Answer questions from Suppliers

### **A. Questions and Answers**

- Q9.** We are completing the RFSA Terrestrial Archaeology Services – Supply Arrangement 5P300-23-0054/A for work within in BC. We have one question about the Permit Holder/Principal Investigator. The RFSA indicates this role needs to be filled by an individual with a graduate degree. My understanding is that there are exceptions to this, and it relates to individual provincial standards/policies. I am a Senior Archaeologist and Field Director able to hold provincial Heritage Conservation Act permits throughout BC with 20 years of experience, but do not have a graduate degree. I have held several PCA Research and Collection Permits in BC since 2016. Would I continue to be able to act as Principal Investigator and Permit holder under the present RFSA?
- A9.** Concerning the RFSA, there are no exceptions for BC or any other region in Canada. Parks Canada maintains that the Principal Investigator must have a graduate degree in archeology or anthropology with a specialization in archaeology. Parks Canada's standards include educational requirements that are carefully developed to meet the needs of our organization for Suppliers and their staff. This is the same standard that Parks Canada imposes on the archaeologists it hires. In addition to the fact that this supply arrangement standardizes educational requirements across all regions of Canada, it is also the standard found in most provincial and territorial jurisdictions for holding a license to operate. We would also like to emphasize that individuals who do not meet the education requirements are not prevented from fulfilling contracts issued under a Supply Arrangement. Individuals who do not meet the education requirements may contribute to a contractor's project team but will not be able to hold the role of Principal Investigator.
