

Question 8	Reference CM3: CM3 states: "The Bidder must identify the proposed client manager that would be responsible for any resulting contract. The Client Manager identified must be or have been a Client Manager of one of the contracts identified in CM3".
	Could Transport Canada please confirm that this should state "CM1' and not "CM3"?
Answer 8	Canada has reviewed your request. See Amendment 1, Answer 2.
Question 9	To ensure Transport Canada receives responses from bidders with relevant experience that directly aligns with this RFP's SOW, please confirm that the "TBIPS Stream 1: Applications Services Category" used by bidders in Corporate Mandatory (CM) 2 Form (B) must be the exact categories listed in CM2 (i.e., A.1. Application/Software Architect, A.7. Programmer/Analyst, and A.12. Web Architect), and that similar resource categories will not be considered.
Answer 9	Canada has reviewed your request. See Amendment# 1, Answer 1.
Question 10	Is there someone currently, or has there been someone in the past providing similar or relevant services? If yes, who has been providing these services, what is (or was) the contract value and what is (or was) the duration of the contract (including any extensions), and are the allowed to bid on this opportunity?

Question 13	If the contract isn't a TBIPS contract with a direct category match, will the Crown implement a signed client letter attesting to the resources provided doing the same/similar work through task mapping at over 80% of the tasks in the RFP SOW?
