1. Provide answer to question from potential suppliers.

QUESTIONS AND ANSWERS:

Question #	Questions and Answers
Question 43	AMD 005, Q&A #42 resulted in the Crown amending the previous answer given on Q&A #25 in AMD 004. In that amendment, the Crown stated that for contracts to now qualify for CM2, "the number of billable days must be 7,000 per contract in one or more of the identified categories."
	This is a significant jump in required demonstrated billable days per contract, and bidders have already spent 2 weeks preparing their proposals and obtaining client signatures based on the original RFP requirement of 7,000 cumulative billed days across four (4) contracts, with each contract requiring a minimum of 1600 billable days. This also contradicts the answer given in Q&A #33, where bidders are instructed to refer to items a) through e) in CM2 for the criteria contracts must meet in order to be accepted.
	Can the Crown confirm this was an error and confirm bidders should follow the original CM2 instructions requesting, "using up to four (4) contracts, the Bidder must demonstrate its experience supplying cumulatively, 7000 billable days" and each individual contract must have a minimum of 1600 billable days.
Answer 43	Canada has reviewed your request and confirms that a compliant bid must demonstrate the number of billed days in one, two, three or any combination of the resource categories identified using up to 4-contract references to fulfil the 7000 billable days.
	Of the 4-contract referenced, each contract must demonstrate a minimum of 1600 total billable days, within one, two, three or any combination of the resource categories identified. (A.1 Application/Software Architect, A.7 Programmer/ Analyst or A.12 Web Architect).
Question 44	Corporate Mandatory Technical Criterion CM2 on page 67
	As has already been pointed out by other Bidders, the restriction to direct match core resource categories severely limits otherwise qualified Bidders from responding to this solicitation. We are concerned that the Crown is at risk of receiving few to no responses, and subsequently at risk of receiving a lower quality of service than desired.
	To mitigate the risk, we request that the Crown accept up to 5,000 billed days in direct match categories, and 2,000 billed days in similar TBIPS resource categories provided demonstration of at least 50% of the tasks identified in the Statement of Work.
Answer 44	Canada has reviewed your request and CM2 remains as is.

Question 45	Please confirm that the intent of CM2 is for bidders to demonstrate, using up to four contracts, that they have collectively billed a minimum of 1,600 days in each subject core resource category, and 7,000 days in any combination of categories, within the last three years.
Answer 45	Canada has reviewed your request, See comprehensive Answer 43.
Question 46	Please confirm that for an individual contract to qualify in CM2, it must have billed a minimum of 1,600 days in any combination of subject core resource categories.
Answer 46	Canada has reviewed your request, See comprehensive Answer 43.
