This amendment 01 is raised to address the following:

• To respond to questions received during the solicitation period

QUESTIONS AND ANSWERS:

- **Q1:** Reference to Annex A: The list of requirements is out of date as it lists a "bellyband", which is very old technology and has since been replaced with Dual Hook HEC Systems. The latest technology provides Dual Hook HEC Systems which is TCCA and FAA certified. Will Canada accept Dual Hook HEC Systems technology instead of old bellyband technology? This was accepted by Canada in A version of this solicitation.
- A1: Yes, so long as it meets Table 5.1.1. Minimum Specifications. Please demonstrate that the "bellyband" has since been replaced with Dual Hook HEC Systems.
- Q2: Reference to Annex A: "Adjustable restraint "Y" style lanyard compatible with the Airbus AS350 s eries helicopter and designed to secure a crew person in the rear of the helicopter cabin, with the ability to adjust as necessary to lean out of the cabin and / or move around in the cabin 1 required Color Black." This was required with the bellyband for an essential crew in the aft cabin to release the bellyband in an emergency. With our system this is no longer required and all doors can stay on with crew inside. it is not required as part of the new technology STC. Please confirm we do not have to supply this as a part of our new technology system.
- A2: The lanyard, as referred to or equivalent, must be supplied.
- **Q3:** Reference to Annex A: The new technology does not dictate any colors for the accessories listed in the solicitation. The new accessories and lines are mostly red and blue. Will Canada accept this?
- A3: Yes
- **Q4:** Reference to Annex A, Delivery Date: Current lead time of the requested system is 16 weeks ARO, considering it is not clear when the contract will be awarded, delivery before May 31, 2024 is not realistic. Will Canada accept 16 weeks delivery timeframe?
- A4: Yes
- **Q5:** Reference to Annex A, Delivery Date: Training of the system should be completed 1 month after delivering of the system not 1 month after award. First the equipment should be delivered and then training should be completed. Please confirm training one month after delivery is acceptable.
