Question 1:

5.1 - 1. h) "One (1) set of airframe battery(ies) for the required minimum flight time."

5.2 - 1. c) "Two (2) sets of airframe battery(ies) for the required minimum flight time"

Could you kindly confirm that this means the total battery(ies) required for the RPAS system + accessory package is 3 sets per RPAS?

Answer 1:

Three (3 ) battery sets are required in total per RPAS and Accessory Package. One (1) set must be supplied with the RPAS system and two (2) sets with the Accessory Package.
