#### Question 1:

Language requirements in the Statement of Work indicate that candidates must speak English, however M7 indicated that "The Bidder must be able to provide services in both official languages". Services are typically delivered through proposed resources that bidders are contracting, can the Crown confirm that M7 refers to proposed resources, rather than the bidder. If so, can the Crown confirm if the language of work is English or bilingual

#### Answer 1:

The bidder must provide the services in English (Note: see solicitation revisions)

#### Question 2:

Section M6 notes that 60 months experience is required "working in an occupational health capacity in a police or military organization or of a similar safety-sensitive occupational group". Is it mandatory that this experience have been in a police or military organization?

#### Answer 2:

No, it is a mandatory requirement to have experience with a police or military organization or of a similar safety-sensitive occupational group. (Note: see solicitation revisions).
