The amendment to the bid solicitation is to address the enquiries received:

- Q1. Re: Drawing # E02, Drawing note that states "Replace EXTERNAL VFD 15HP/20HP/30HP VFD". Please define "External". Does this indicate that the referenced VFD is located in a remote position in relation to the MCC or is this VFD contained within the existing bucket of the MCC?
- R1. Noted External VFD's are surface mounted adjacent and in close proximity to MCC #11 but not within an MCC bucket.
- Q2. Re: Drawing note that states "Replace EXTERNAL VFD 15HP/20HP/30HP VFD": If these VFD's are mounted in remote location, and not within the MCC, is there any scope required for the associated disconnect contained in the existing MCC?
- R2. MCC# 11 buckets related to External VFD's to be provide with new components per information provided on drawing.
- Q3.Re: Drawing # E02, Drawing note #1 that states "Provide new blank front cover `plate". Do the existing buckets, requiring new front plates presently have any disconnects/starters that require removal?"
- R3. Refer to MCC 1 Study Documents provided in the Tender package. Existing buckets shown on drawings with Note 1 indication are empty buckets to be provided with new blank front cover plates.
- Q4. Re: Drawing # E02, Drawing note #2 that states "Remove wiring back to source". Work associated with this scope item cannot be calculated based on the information presently provided. Please provide as built single lines/schematics indicating wire sizes, and lengths required for removal.
- R4. Please refer to the revised pricing table for a cash allowance.
- Q5. Re: Drawing # E02, Drawing note #2 that states "Remove wiring back to source". Does the associated raceway also have to be removed? If so, we require as built drawings showing conduit routing or estimated conduit lengths to be removed.
- R5. Associated raceways to remain.
- Q6. Re: Drawing # E02, Drawing note #3 that states "Remove Bucket & wiring back to source". Work associated with the "wiring" scope portion cannot be calculated based on the information presently provided. Please provide as built single lines/schematics indicating wire sizes, and lengths required for removal.
- R6. Please refer to the revised pricing table for a cash allowance.
- Q7. Re: Specification Scope Items #1.1.4, & 1.1.6: Please provide a detailed specification for the new VFD's, as required. At present the VFD manufacturers that we have reached out to have indicated that there is not enough information to provide a quotation.
- R7. The existing MCC #11 VFD's are as noted below. Replacements VFD's to be similar, one manufacturer, industrial duty, 600V and HP rating to match existing.

Appendix 1 Price Form, Price item which states, in part "Electrical equipment Supply of ... variable frequency drives (VFD) and all related interior components of the MCC#5 as per specifications and drawing documents" and Drawing # E01 (MCC #5 Section Drawing: The Tender Form Price Item indicates the requirement for the supply and install of "variable frequency drives" yet during the site visit of June 26th verbal directive, it was indicated to the Contractors present that there are no VFD replacements required for MCC #5 (Existing GE Unit), please confirm and revise the Tender Form accordingly.
- R10. E01 (MCC#5) does not have any external VFDs. Please indicate a value of the equipment required that is related to each MCC as per drawings.
- Q11. MCC #5 (Existing GE Unit) Drawing #E01 there is an existing 50A Spare disconnect switch, yet during the site visit it does not appear to be installed nor does it show on the "MCC #5 CCIW Study" handed out during the June 26th Site Visit. Is a new 50A spare breaker required as part of the Tender?
- R11. R1-7 is a spare breaker to be added during the new installation and is not existing.
- Q12. MCC #5 (Existing GE Unit) Drawing #E01 there is an existing 30A Spare disconnect switch, yet during the site visit it does not appear to be installed nor does it show on the "MCC #5 CCIW Study" handed out during the June 26th Site Visit. Is a new 30A spare breaker required as part of the Tender? R12. R2-8 is a spare breaker to be added during the new installation and is not existing.
- Q13. Is there a requirement for the Contractor to included for a Coordination Study, arc flash study(labeling) etc. for this project?
