A. Provide clarification and answers to questions from potential suppliers.

1.2 THIS SOLICITATION IS HEREBY AMENDED AS FOLLOWS:

A. Questions and answers:

Question 1	With respect to Annex A, Part 3.2.3 (c); are you able to confirm whether TC will provide a database of the current fleet with all required data (crew size, voyage limitations, vessel type, dimensions, cargo, etc), in excel or similar format?
Answer 1	Transport Canada will provide an anonymized list of vessels with key data, but not all information is available for all vessels. For vessels below 15 gross tonnage, that are not certificated the data is mostly limited to the data available in the Vessel Registry.

Question 2	Does the SOW refer specifically to commercially operated vessels, or does it include pleasure craft?
Answer 2	The SOW does not include pleasure craft.

Question 3	We assume that this SOW includes fishing vessels – can you confirm?
Answer 3	The SOW includes all type of vessels, other than pleasure craft.
