Question 1	With reference to Solicitation T8080-220644 Environmental Scans we notice that Points Rated Technical Criteria R2.1.3 The Bidder should demonstrate using project descriptions that the proposed Project Manager has a minimum of 2 years' experience in the following elements: a. Analyzing transportation safety data; is a copy of the wording from Risk Analysis of the Canadian Maritime Fleet, Solicitation No. T8080-220645. We wonder if this (Analyzing transportation safety data) is strictly necessary given the wording around the rest of the SoW and if this requirement might be deleted.

Question 2	It is concluded, but please confirm, that Transport Canada will facilitate the approach to Foreign and Commonwealth administrations mentioned in ANNEX A - STATEMENT OF WORK Para 3.1.2 a
