Grafting services for the rejuvenation of the apple germplasm collection maintained at the Canadian Clonal Genebank

REQUIREMENT:

Grafting and planting services for the regeneration and rejuvenation of the Apple Germplasm Collection at the CCGB, using certified virus and disease resistant GENEVA® 11 and GENEVA® 41 apple rootstock.

Spring 2023: Grafting and planting services for 3,000 dormant bud-wood from CCGB orchards.

Summer and Fall 2023: Grafting and planting services for 2,000 active growing bud-wood of grafted accessions, difficult or weak and sensitive apple trees varieties.

In subsequent years, the same steps will be repeated, and deliverables are estimated to be 2,800 rootstock and 2,800 grafts and planted trees for the 2024-2025 fiscal year, and 2,800 rootstock and 2,800 grafts and planted trees for the 2025-2026 fiscal year.

SOLE SOURCE JUSTIFICATION:

The UCG is the sole licensed contractor in Canada to grow and distribute GENEVA® 11 and GENEVA® 41 apple rootstock. The CCGB requires this specific rootstock for its dwarfing, virus free and disease-resistance properties.

UCG is located in proximity of CCGB (4.5km) for effective and safe transportation of the material, and is the sole contractor able to collect fresh calibrated size scion-wood of the 1,460 accessions from five orchards at the CCGB.

Grafting has a much higher success rate for both rootstock and scion-wood when the transportation time is reduced to a minimum. The rootstock will be already on the UCG location. It would increase the contamination possibility and decrease scion viability and grafting success significantly if we were to ship it to another location for the grafting process.

CRITERIA FOR ASSESSMENT OF THE STATEMENT OF CAPABILITIES:

- -Contractor must provide proof that they are licensed to grow and distribute GENEVA® 11 and GENEVA® 41 apple rootstock in Canada.
- -Contractor must provide proof of performing bench-grafting in their facility.
- -Contractor must provide proof of performing micro-grafting techniques and have facilities where rootstock and micro-grafted trees will be grown for two months.
- -Contractor must provide planting ellipots and proof of safe transportation platforms for the grafted trees back to the CCGB-ACAN.
