## Solicitation Amendment

Title Aviation Professional Services

Solicitation Amendment No. 003

This solicitation is hereby amended to provide the following questions and answers.

- Q4. Approximately how much of the work conducted under this contract requires the use of a protected network / IT asset; and would it be acceptable to the Crown to execute portions of the work on a generalized network?
- R4. Some of this work could be proceed on a general network when the information is unclassified in nature. Protected (restricted) information must be processed on a protected network.
- Q5. Can the Crown clarify the purpose of the security requirement, and whether those requirements would allow international resources to support this requirement?
- R5. Yes, the security requirements would allow international resources to support the requirement. Should the successful bidder/vendor be a foreign entity and there is a requirement to process sensitive information, Transport Canada would communicate with Public Works and Procurement Canada's International Industrial Security Directorate so they may proceed with the inspection requirements for the vendor.
- Q6. Can the Crown provide additional detail on the schedule and the level of effort that is required? Is the work expected to be discrete work packages, that may not span the full period of performance or is it expected that the level of effort will be evenly distributed over the period of performance (i.e., ~9 hours per week over 3-years).
- R6. The work will likely have times of increased workload requirements and times where the workload will be less. The level of effort that will be required will be established as the project work is underway.
- Q7. Can the Crown clarify Annex B. Is the level of effort 500 hours for one resource, or is the Crown seeking a full team to execute the work?
- R7. The estimated number of hours provided in Annex B, is to carry out the work associated with the tasks outlined within *Annex A Statement of Work*. The bidder must provide a firm hourly rate to carry out those tasks, whether it be for a team or an individual resource.
- Q8. Additionally, is Annex B asking for a per-resource hourly rate, or a per-team hourly rate?
- R8. The hourly rate is to carry out the tasks outlined within *Annex A Statement of Work*. The bidder must identify if they would require a team of resources or an individual resource and submit one hourly rate.

All other terms and conditions of the solicitation document remain unchanged.
