Further to the above- mentioned Request for Proposal documentation previously forwarded to your firm, Addendum (#3) is hereby issued.

Questions and Answers

- Q1. Refuse location #1 – 20 yard container – Please note that this is a 30 yard closed top container. Please also note that this type of service is charged for the haul of the bin plus the disposal amount for the material in the bin once it is weighed at the landfill. There is not currently a space in the spreadsheet for the per tonnage rate for disposal on this bin.
- A1. Service is charged for the haul of the bin plus the disposal amount for the material in the bin once it is weighed at the landfill “ I suggest to take an average of what they would think a 30yard container full would cost per tonnage (+ or -) on cost.
- Q2. There is a 6 yard for plastics located by the bridge – locations #4 as indicated in your pricing sheet. This bin is not on your sheet.
- A2. See revised tables on Pg. 6, 7, 8 & 9.
- Q3. The 6 yard paper/cardboard bin is sized as a (1x6) Gallon cart on the pricing sheet but is in fact a 6 Yard bin at location #4.
- A3. See revised tables on Pg. 6, 7, 8 & 9.
- Q4. There is a 6 yard waste bin by the boathouse that is not listed on the pricing page.
- A4. See revised tables on Pg. 6, 7, 8 & 9.
- Q5. The construction debris 6 yard (location # 5) and the Metal Scrap 6 yard bin (location # 6) are actually open top 20 yard bins. These would need to be priced by the haul plus the disposal charge per ton as previously noted on location #1.
- A5. Service is charged for the haul of the bin plus the disposal amount for the material in the bin once it is weighed at the landfill “ I suggest to take an average of what they would think a 30yard container full would cost per tonnage (+ or -) on cost.
