The amendment to the bid solicitation is to address the enquiries received:

Response(s) (R) to Question(s) (Q)1:

Q1. Chain of custody is important, but you abdicate this responsibility when you provide samples to labs. These samples will be shipped 1000's of kilometer in possession of a courier over which Environment and Climate Change Canada (ECCC) or the contract lab has no control. Why is ECCC not concerned about this out of province shipment?

R1. The laboratory is responsible for maintaining chain of custody and ensuring the samples are analyzed according to the prescribed methods.

Q2. Please explain why ECCC personnel are unable to make a 2-3 hour return trip in a given day. Why is it not acceptable to drive 45 km to drop off samples?

R2. ECCC has extended the range, please refer to revised mandatory criterion 4 below.

Q3. Can ECCC provide an estimate of the potential batch size or sampling frequency?

R3. ECCC anticipates sampling this July and October, and will confirm the sample size following the initial meeting with the laboratory. Potential sample size and sampling frequency per year is identified in Table A5 of the Statement of Work.
