Amendment 006

This amendment is raised to:

- A. Answer questions from bidders; and
- B. Amend Annex A Requirement and Basis of Payment.

A. Questions and Answers

- Q1. With regards to question 5 in Amd 003, we do still have a concern that the number of lockers and the requested layout will not fit as desired. The manufacturer has a concern that without proper spacing between the lockers at the corner locations, the storage locker doors will hit each other. Additional space between the lockers and additional front fillers would be recommended for this layout to work. Due to the amount of space available and shown in the sketch provided, at this time we would suggest removing NSA item 21 from the bid requirements.
- A1. Due to these additional concerns and project timelines, Parks Canada has reviewed the requirement and decided to remove the entire NSA section of Category 1, 2, and 5 from this solicitation to allow for further development of these items. See changes made to Annex A below.
- Q2. Cat 6 Kitchenette Furniture, Item 3, Can you please confirm the height of this Kitchenette Island Table? The requested height is 34-37"H which is a counter height, but the chairs being requested (item 2 20 in total) will be standard height. Please confirm.
- A2. The table measurement height should be 29". See changes made to Annex A below.

B. Amend Annex A – Requirement and Basis of Payment

Bidders <u>MUST</u> submit their bids in accordance with the Requirement and Basis of Payment changes included herein. Bids that are not submitted in accordance with this amendment will be deemed non-responsive to the solicitation requirements.

Under Annex A – Requirement and Basis of Payment, amend the following.

- Under "Product Category(ies): 1, 2, 5, and NSA: Table 1 Product Table", DELETE the NSA section in its entirety, inclusive of line items 19, 20, and 21 and DELETE all references to "NSA", and to item numbers "19", "20", and "21".
- Under "Product Category 6 Kitchenette Furniture; tables, chairs, stools: Table 1 Product Table" delete the GoCUID and Description of Product of item 3 in its entirety and replace it with the following:
