Question: On W8486-238852 Section 6.1
6.1 Security Requirements
6.1.1 There is no security requirement applicable to this Contract.

There are 10 line items that require Chemical Agent Resistant Paint, this is a controlled goods product. Should the security requirements have Controlled goods as required? Alternatively, is the intent to have those items delivered not painted?

Response: The statement under Section 6.1 is accurate. There are no security requirements applicable to this requirement.

The items in question are to be delivered painted. The Chemical Agent Resistant Paint (CARC) is a controlled goods product however once it is applied to a surface and dried it is no longer controlled. The coating does not change the status of the coated item. For example, a commercially available electrical generator painted with green CARC remains a non-controlled good.
