1. Questions and Answers:

Q1. In the past 3 years – who currently did/is doing the work?

A1. Simplex Industries Inc.

Q2. In the past 3 years, what is the \$ spent each year on similar/related services?

A2. Approximately:

2020-21--- \$137,000.00

2021-22---\$118,000.00

2022-23---\$111,000.00

Q3. What is the expected spend per year over the course of the contract (including options)

A3. The spend per year will be based on bid pricing.

Q4. We do not see any consideration for evenings/weekends for OT – as of January 1, 2018, all employers must compensate workers for OT as per Bill 148 in Ontario. We respectfully request an amendment to address the ability to provide overtime rates in accordance with legislative changes that we are mandated to.

A4. As stated on page 19 of the bid under “Hours of Work”, overtime will not be paid by the PCO unless approved in writing. In the event it’s approved by the Project Authority, it will be paid at the rate of time and one half.

Q5. One vendor or Multiple vendors being requested as part of a standing offer?

A5. This solicitation is not being issued under any Standing Offer. There will only be one contract awarded as a result of this solicitation.

Q6. In the mandatories M3 it is indicated that the involve workplace moves at Municipal, provincial and federal government level. What is the difference between the 3 level when it comes to dismantling furniture, moves and warehousing?

A6. There is no specific difference between workplace moves at the three levels. This was used as a bullet to prove experience of providing moves at each of these levels.
