This amendment is raised to:

- A) Answer questions from bidders;

A. QUESTIONS AND ANSWERS

- Q1** Please confirm if firms are permitted to pursue two different zones in two different capacities? For example, can a firm pursue the Alberta region as a Subconsultant to another firm, and pursue the British Columbia region as Prime Consultant?
- A1.** There is no issue with this example. To go further one firm could be the Prime Consultant in multiple regions if they obtained the highest combined rating of technical merit and price in those regions.
- Q2.** Please advise when the client is anticipating awarding the contracts? We note that December is listed in the milestone schedules for WP2, however this is getting very late in the year for assessments and may hinder consultants ability to review the landscape, civil, and exterior envelope components of the buildings depending on weather in each region.
- A2.** Once the evaluations are completed, between June 29, 2023 and the second week of July 2023.
