#### IMPORTANT NOTICE TO BIDDERS

#### TWO STAGE SELECTION PROCESS

This is the first stage (Stage one) of a two-stage competition: the first stage will evaluate the qualifications of all bidders; second stage (Stage two) will invite the qualified bidders to provide a financial bid on the project based on the specifications and drawings. Upon award of contract in Stage Two the pre-qualification list will expire and will not be used in any other solicitation. The qualification list will expire within 180 days or upon award of a contract in Stage Two, whichever is earlier, and the prequalification list will not be used in any other solicitation.

## **SPECIAL INSTRUCTIONS TO BIDDERS (SI)**

#### TWO STAGE SELECTION PROCESS

This is a two stage selection process. Bidders responding to this selection process are requested to submit a bid in two stage. Stage One bid covers only the qualifications and experience of the Bidder.

Following the evaluation of the submissions, Bidders will be advised of their qualification result and the status of the tender. Stage Two Bidders will be provided an INVITATION TO TENDER (ITT) for the financial evaluation in relation to the specifications and drawings. Please refer to sample ITT attached (Appendix 2). Please note that the ITT used in Stage 2 of this process will be a Single Envelope ITT with a Low Price Basis of Selection. The attached sample is only being provided for bidders to reference the General Conditions.

## **OPTIONAL SITE VISIT**

There will be no site visit for Stage 1.

#### **ENQUIRIES DURING THE SOLICITATION PERIOD**

- 1. Enquiries regarding this bid must be submitted in writing to the Contracting Officer named on the Invitation to Tender Page 1 at e-mail address <a href="mailto:clos.pelland-tessier@pc.gc.ca">cloe.pelland-tessier@pc.gc.ca</a>. Enquiries should be received no later than five (5) business days prior to the date set for solicitation closing to allow sufficient time to provide a response. Enquiries received after that time may result in an answer NOT being provided.
- 2. To ensure consistency and quality of the information provided to Bidders, PCA will examine the content of the enquiry and will decide whether or not to issue an amendment.
- 3. All enquiries and other communications related to this bid sent throughout the solicitation period must be directed ONLY to the Contracting Authority named in paragraph 1. above. Failure to comply with this requirement may result in the bid being declared non-compliant.

#### APPENDIX 1 – STAGE ONE QUALIFICATION REQUIREMENTS

#### **DESCRIPTION:**

This project will be carried out within the Cape Breton Highlands National Park (CBHNP) in Nova Scotia. The project will involve the supply and install of four (4) road closure gates (one on each side of the Cabot Trail) at two locations in CBHNP: near Big Intervale and Pleasant Bay. The purpose of the gates is to allow for road closures on both lanes of the Cabot Trail on either side of North Mountain in the event of severe weather/poor driving conditions. In addition to the gates, the project also includes the supply/installation of streetlighting at gate locations and protective roadside barriers along with associated civil/electrical work.

Specifically, construction will involve:

- Labour, plant, material, tools, construction machinery and equipment, water, heat, light, power, transportation and other facilities and services required to perform the work.
- Site preparation consisting of surveying, grubbing, excavation, grading and landscape reinstatement.
- Concrete work consisting of excavation, formwork, reinforcing, and concrete placement for gate/light posts.
- Supply and installation of gates and light posts.
- Highway shoulder widening (for vehicle turn-arounds) consisting of excavation, placement of suitable granular materials, grading, compacting, and asphalt if required
- Installation of substantial highway safety measures including highway guardrails and bollards
- Supply and installation (and modification) of permanent highway warning signage / flashing lights.
- Electrical services installation (underground and/or overhead) and may include electrical transformer installations and highway cutting, excavation, service installation and patching with asphalt.
- The work involves multiple trades and suppliers and must be coordinated by a General Contractor. Furthermore, the General Contractor shall be responsible for Occupational Health and Safety on site including traffic control during construction.

Successful bidder will have until October 27, 2023, to complete the work.

Bidder Instructions: The Bidder is requested to respond to the Stage One Evaluation Criteria using the tables below.

#### **BASIS OF SELECTION:**

A submission must comply with the mandatory requirements to be declared responsive in Stage One.

## **MANDATORY REQUIREMENTS:**

At Stage One bid closing time, the Bidder must:

- a) comply with the following Mandatory Requirements; and
- b) provide the necessary documentation to support compliance.

All Mandatory requirements should be completed and submitted prior to closing with sufficient detail to demonstrate compliance. Failure to demonstrate compliance with all mandatory requirements via the original submission, may result in the submission being deemed non-responsive. At any time in the evaluation stage should PCA officials identify any minor irregularities or omissions the Contract Authority may inform the proponent of a time frame within which to provide a clarification or missing information. Failure to comply with the request of the Contracting Authority within the time frame provided will render the submission non-responsive.
