Amendment 02 is raised to answer the second round of bidder questions.

RFP Amendment 01 - 14 June 2023

Question 1:

Since most hotels in the Rockies mountain area do not house laundry machines, my question was if the DND personnel can do their own laundry at a facility located about 100 metres from the main hotel.

Answer 1:

Yes, the Crown is in agreement to allowing DND personnel to do their own laundry at a facility located about 100 metres from the main hotel. Please note the other requirements of MT.8 are required to be fulfilled.

Delete: MT.8 in its entirety; and

Insert:

MT.8

The Bidder should clearly demonstrate that it is capable of providing either;

- 1. Laundry services for each member, two (2) times per week; or
- Provide two (2) each operational washers and dryers for personnel to use, within one hundred (100) metres from the hotel, with the accompanying laundering materials. Machines should be available between 0600-2200.

In order to meet this requirement, the Bidder should provide confirmation of either:

- 1. Laundry services for each member; or
- Provision of two (2) washers and (2) dryers for personnel to use within one hundred (100) metres from the hotel.
 Laundering provisions, such as detergent, dryer sheets will be provided. Machines should be available between 0600-2200.

Question 2:

Since the closing date [of submission] is very close to the start date which also happens to be peak summer season, can the Technical Authority review and select the winning vendor about 72 hrs after closing date [of submission]?

Answer 2:

The Crown understands that there is a short lead time for this requirement, and we will endeavour to award the contract as soon as possible. However, we cannot guarantee a 72h timeframe.

RFP Amendment 02 - 16 June 2023

Question 3:

One quick question, if the facility offers coin operated guest laundry on site, does the Annex B - Basis of Payment (B) Laundry Self Service need to indicate any price or can we leave it as "0". The intent is that the CAF members will pay for their own use of the laundry.

Answer 3:

If the facility offers coin operated guest laundry on site, the Annex B - Basis of Payment (B) Laundry Self Service would need to indicate the price. It is the Crown's intent to incur the costs as contracted and that the CAF members will not pay for their own use of the laundry at time of use. Please note that if the Bidder is to provide Laundry Self Service, accompanying laundering materials should be provided as well as access to machines between 0600-2200 as set out in MT.8.
