(B) QUESTIONS AND ANSWERS

1. Question: We have built many towers up to 200Ft tall, well above your 60Ft requirement, some with multiple towers at each site. None have been even close to 500K. Can you lower or remove the dollar value for the projects? Most owners supply the towers to lower the contracts as well.

Answer: This build will be a complete radio site consisting of supply and install tower, shelter, back-up generator and elevated platform as we are building in a flood zone. We cannot buy the tower and shelter in advance. If you have a previous contract of installing a tower and shelter but not purchasing the actual tower and shelter add it in as required.
