1. Amend Answer #1 that was originally released in Amendment #2 to Solicitation W6369-23-X047, removing the requirement for an adjustable monitor; and
2. Delete Mandatory Criterion MA3, which required a height-adjustable monitor.

Question #1	In reference to Mandatory Technical Criteria line MA3, The OEM has confirmed the monitor is in a fixed position and won't need to be adjusted. Please confirm if it will be acceptable.
Answer #1 (amended)	<p><del>John Bean part number EEWA552HV2 includes an adjustable monitor. Bidders must clearly demonstrate that their proposal meets all of the requirements of the Request for Proposal (RFP), including but not limited to all of the mandatory criteria identified in the RFP, in order to be given further consideration.</del></p> <p>Mandatory Criterion MA3 is hereby deleted from the solicitation as per the solicitation amendment below.</p>
Question #2	The OEM informed us that the monitor of John Bean PN# EEWA552HV2 is not adjustable. It's the cameras that are adjustable and auto-tracking. You can move the monitor to a different height, but it would require additional length data cables and wouldn't make sense to do it. Please advise.
Answer #2	Mandatory Criterion MA3 is hereby deleted from the solicitation as per the solicitation amendment below.
