Description of Work:

Objectives of Requirement:

- *To focus on the strategic implementation of a broad reaching Business Intelligence solution for multiple internal stakeholders that fully integrates relevant data governance, data modeling, and advanced analytics approaches and tools.*
- *To support an implementation strategy to achieve DCFO's goals and business interests including, but not limited to the integration of results reporting within the Business Intelligence strategy.*
- *To identify gaps and investigate emerging technologies, as required*

As such, the Public Health Agency of Canada has a requirement for one Business Consultant to support the strategic implementation of a comprehensive Business Intelligence solution for multiple internal stakeholders. This solution aims to fully integrate relevant data governance, data modeling, and advanced analytics approaches and tools. The consultant will also play a vital role in supporting the implementation strategy to achieve DCFO's goals and business interests, including the seamless integration of results reporting within the Business Intelligence strategy. Additionally, the consultant will be responsible for identifying any gaps and conducting investigations into emerging technologies, as required.

The demand for a fully integrated Financial Business Intelligence reporting solution is driving significant and extraordinary changes to the operations and business processes of PHAC. There is a requirement to aggregate, synthesize, statistically model and reconcile large amounts of data from multiple data sources (both internal and external) in a short timeframe. Internal PHAC business processes and infrastructure are not optimally developed and lack data governance and oversight. We require the assistance of a business consultant with subject matter expertise in data management, business intelligence, data governance and statistical modelling to help develop and implement and Business Intelligence strategy. The resource will need to provide intellectual leadership to other members of the team and other key internal stakeholders in the areas of Business Intelligence, data governance, statistical modelling, data engineering and advanced analytics including Artificial Intelligence (AI) and Machine Learning (ML) approaches.

The TBIPS Level 3 B.3 Business Consultant will be required "on an as and when needed" basis over a period of one (year) with an additional three (3) one year Option Periods. Task Authorizations (TAs) will be issued against Service Outline Agreements to support the various Public Health Agency of Canada initiatives.
