## **Questions and Answers**

- **Q27.** If a Firm is submitting on more than one category, will PCA accept submission of one (1) Part A Management and Corporate section and one (1) Indigenous Participation Plan, in lieu of submitting repeated information for all sections?
- A27. Yes, if a bidder is submitting on more than one stream, only one Management and Corporate section and only one Indigenous Participation Framework is required.
- Q28. Will PCA accept US National Parks Heritage filing process as equivalent to FHBRO review process?
- A28. Preference will be given to consultants with experience working within the Canadian FHBRO system, and in particular to those having completed projects in which the "Standards and Guidelines for the Conservation of Historic Places in Canada" were successfully applied. In lieu of such experience, consideration will be given to those who have worked in a heritage protection capacity under other national frameworks
- **Q29.** Please confirm PCA is looking to evaluate one (1) project per sub-category in each Category submission.
- A29. There is no minimum or maximum project requirements. The Offeror should select projects and present them in a way to highlight requested experience within the allotted page quantity limits.
- Q30. Will PCA accept one project description per overall category that makes reference to each of the sub-categories within the one project description?
- **A30**. Yes
- Q31. Can Parks please confirm if the Junior Professional is required to have a P.Eng. designation or if a EIT with the appropriate number of years experience is acceptable?
- A31. P.Eng Designation is not required for Junior Professionals: registration as an EIT. AScT. or C.E.Tin BC and/or Alberta is acceptable.
- Q32. Can Parks please clarify what designations/accreditations are acceptable/required for Senior and Intermediate Professionals under the "Green Building/Sustainable Design" categories (e.g., P.Eng., P.E., AScT.)?
- A32. Senior Professionals and Intermediate Professionals in all disciplines must be registered as a P.Eng. in BC and/or Alberta.
