1. The solicitation is hereby amended to provide the following questions and answers:

Question 5

Would you please advise if there has been firm, or individuals engaged by Veterans Affairs performing similar duties as noted in the SOW of the RFP over the past 24 months?

Answer 5:

Veterans Affairs Canada's International Operations Directorate is responsible for Canada's overseas memorials and this is the first engagement for a Contractor to provide the duties outlined in the SOW of the RFP.

Question 6

Is there an expected budget for this project besides the 20,000 Travel and Living expense indicated in the RFP or is the expectation for the applicant to provide the cost estimation?

Answer 6

Bidders must submit their financial bid in accordance with Annex B Basis of Payment. The Bidder is to determine their financial bid to complete the requirement outlined in Annex A Statement of Work.

Question 7

The RFP references broad aspects of accessibility (for example, sensory and neurodiversity) however the example standards only reference the built environment. Can you confirm whether the accessibility assessments should include standards or other components beyond the accessibility of the built environment (for example, accessible customer service, accessible websites, and digital presence, etc.)?

Answer 7

Accessible websites and digital presence are the responsibility of another area within Veterans Affairs Canada and, as such, are not required in this assessment. The successful Contractor is expected to begin the assessment from the point at which a visitor arrives on site and from the perspective of an employee on site.

Question 8

The mandatory and point-rated criteria listed in the RFP (pages 28-30) relate to the organization and project lead, but we are allowed to include a maximum of 5 supporting resources. Please confirm our understanding that the only the project lead and organization are being evaluated for mandatory and point-rated criteria and the supporting resources are not.

The organization and the project lead are being evaluated for mandatory and point-rated criteria.

Question 10

Table 3: Deliverables Timeline under section 2.5. Timeframe and Deliverables states that research and site visits are to begin during the Summer of 2023. However, given the timeline of the proposal it seems likely that this window will be missed upon project award. Is it possible to revise the project timeline and allow for an extension of the deliverables timeline to account for the time missed from the summer of 2023?

Answer 10

Although the timeline might be compressed for some activities, the table is an estimated timeline with a firm delivery for February 29 and March 29/31. The project deliverable remains a limitation in that it must occur before 31 March 2024. It is anticipated that visits could occur in the late October/early November timeframe.
