This amendment is raised to extend the closing date of this RFSA.

As per Part 6, Resulting Supply Arrangement and Resulting Contract Clauses, Clause 6A.4, Period of the Supply Arrangement, and Clause 6A.5, On-going Opportunity to Qualify:

- the PASS SA is intended to be valid for an indeterminate period; and
- it is anticipated that during the SA validity period, there will be quarterly Refreshes. Each Refresh Period provides an opportunity for New Suppliers to submit an arrangement in order to qualify for an SA or Existing Suppliers to submit an arrangement in order to qualify for new Streams or add Regions/Metropolitan Areas for which it has not already been awarded an SA.

Accordingly, the solicitation closing date is extended until December 31, 2100 in order to permit for these quarterly Refreshes. The anticipated Refresh schedule remains unchanged (i.e. aligns with the Government of Canada fiscal year quarters, as indicated in the table in Clause 6A.5). The precise closing dates of each Refresh Period will be that indicated in the Centralized Professional Services System (CPSS). The schedule may require a revision due to operational requirements, in which case Suppliers will be advised.
