

NOTICE OF PROPOSED PROCUREMENT (NPP) – Solicitation Number 2024-00284

This bid solicitation cancels and supersedes previous bid solicitation number 2024-00284 dated August 11th, 2023, with a closing of August 25th, 2023, at 2pm Eastern Time. A debriefing session can be provided upon request to the bidders who bid on the previous solicitation.

Title : Locker Units

The **Canadian Food Inspection Agency** (CFIA) (the « **Client** »), has a requirement for the purchase, delivery and installation of metal filing and storage cabinets to Ottawa, ON by December 15th, 2023.

This NPP is issued pursuant to PWGSC Supply Arrangement (SA) # E60PQ-140003/C and covers a requirement for products that are **Category 3** Metal Filing and Storage Cabinets.

Conditional PSIB Set-Aside :

This NPP covers a requirement to be solicited amongst the General Stream (SA holders) and the PSIB stream of Suppliers (SA holders).

This procurement is conditionally set aside under the federal government Procurement Strategy for Indigenous Business. For more information on Aboriginal business requirements of the Set-aside Program for Indigenous Business, refer to [Annex 9.4](#) of the Supply Manual.

This procurement is conditionally set aside from the international trade agreements under the provision each has for measures with respect to Aboriginal peoples or for set-asides for small and minority businesses. Further to Article 800 of the Canadian Free Trade Agreement (CFTA), CFTA does not apply to this procurement.

This is a competitive bid solicitation however, this solicitation will be reserved for Indigenous Businesses if both of the conditions detailed in the Request for Proposal (RFP) are met. If the conditions are not met, the procurement will remain open for competition among all suppliers.

Trade Agreements :

This requirement is subject to the Canadian Free Trade Agreement (CFTA).

Only suppliers who are pre-qualified and have been issued a supply arrangement are eligible to bid. Non-Supply Arrangement (Non-SA) holders may submit a bid to the Identified User (IU) but must also submit an arrangement to the Supply Arrangement Authority (SAA) for evaluation.

The non-SA holders cannot be awarded a contract unless and until the SAA has issued an SA to that supplier for the products and services contained in the bid. Canada is not required to delay the award of a resulting contract pending the evaluation of an arrangement and issuance of a SA by the PWGSC Supply Arrangement Authority.
